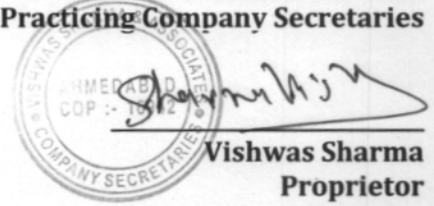
I have verified the Articles of Association of the Company and hereby certify that the Articles of Association of the Company does not provide for any method for determination of floor price.



Accordingly, the floor price in terms of SEBI (ICDR) Regulations is Rs. 83.59/- per Equity Share which has been arrived at Rs. 83.79/- per equity share. The issue price is Rs. 83.79/- which is not lower than the floor price determined in compliance with applicable provisions of SEBI.

- d) The Company is listed on National Stock Exchange of India Limited ("NSE") platform and BSE Limited, accordingly, "NSE" is the Stock exchange on which the highest trading volume in respect of the equity shares of the issuer has been recorded during the preceding 90 trading days prior to the relevant date i.e. Thursday, July 25, 2024.
